Therefore we are requesting a \$100 deposit be paid (cash or check) with your application. Checks should be made out to Omicron Delta Epsilon.

You will be asked to share a hotel room with another student of the same gender and it is possible we may have three people in a hotel room. Again, the club will pay for your shuttle travel and hotel. Leisure travel is the responsibility of each student.

MANY OF OUR HOSTS REQUIRE PROOF OF COVID-19 VACCINATION TO ENTER THEIR OFFICES. THEREFORE, I AM GOING TO REQUEST THAT STUDENTS COMMIT TO BEING ABLE TO PROVIDE PROOF OF VACCINATION IN ORDER TO PARTICIPATE ON THIS TRIP.

The current plan is to fly out of Manhattan, Kansas at 544 PM arriving in Dallas at 706 PM. We will take a shuttle to the hotel and have a group dinner. On Tuesday, most students will return to Manhattan on a 932 PM flight arriving around 11 PM. Some students may take an earlier flight but that would probably require some payments from the student to subsidize the cost of this flight.

Here is a tentative agenda for the trip (The trip will take place March 6-8)

Monday –Monday Morning we will meet with Todd Fecht, CEO of First National Mutual Group – we will discuss investment opportunities dealing with reinvestment,, jewelry and oil and gas.

Monday afternoon we have a meeting planned with Charlotte Lake – Senior VP of Corporate Responsibility for AT&T.

Tuesday – Meet with more business leaders and tour the business district in Dallas. Also meet with the Dallas Federal Reserve about internships and research associateships

We may meet with representatives from Goldman Sachs and Wingstop as well. We might visit AT&T Stadium as well.
