There was a question raised about the rationale being identical for all the new courses. A comment was made as well that there is more concern now with resources and budget so they wanted to be sure what, if any impact there will be. Kingery-Page indicated these are due to an overhaul of the Master of Landscape Architecture degree. She offered to provide a diagram that may assist with the explanation and perhaps have a representative at the next meeting from that department. A brief discussion occurred regarding impact on other units. Landscape Architecture and Horticulture are very separate disciplines and there is no impact related to that. Members voted to table these items and someone will come to the next meeting to give an overview of the curriculum for which these courses will be a part of.

A motion was made by Goodson and seconded by Hageman to approve the following proposal:

College of Veterinary Medicine:

DMP - 817 - Mathematical Modeling in Epidemiology

Victoriya Volkova, from the College of Veterinary Medicine, was present via Zoom to discuss the proposal. There were various questions raised. Members discussed the K-State 8 tag, which is for undergraduate students and would therefore not be appropriate for an 800 level course. To the best of everyone's knowledge, an undergraduate student can't take an 800 level graduate course. However, there was need to determine the fundamental intent of the course. Is the aim for both undergraduate and graduate students? If so, a different course number is necessary, but that seemed to conflict with the pre-reqs for the course. After further discussion, it was decided the course proposal needs additional work prior to a vote from this committee. These questions need answered: Is the intent to recruit undergraduate or graduate students; does a K-State 8 tag need included; and are the pre-requisites appropriate. The proposal was tabled until a future meeting; no vote was taken. Bormann will meet with Victoriya to provide additional feedback.

#### 5. Unfinished Business

A. Athletic department Eligibility monitoring process – Observer Role in Canvas.

Kristin Waller and Bill Banks were present to discuss updates they made to the proposal based on feedback from the committee at the last meeting. Members were still not comfortable with certain parts of the proposal. After discussion, it was agreed that, at least for this year, the default will be opt out rather than opt in. In other words, if a faculty member doesn't respond to a request, it will be an

automatic opt out. Members believed this was appropriate and that faculty will value the ability to become more informed about the process this year rather than be concerned when they notice observers in their roster and don't fully understand what is happening. It was also clear that identifying right up front what the observer role allows someone to view is important. A reminder was given that this method of having the observer role will provide an audit trail, which is not available in the current process. Once the final edits are made to the proposal it will be circulated to members. All were reminded this process will be reviewed in a year. The consensus of the committee was the proposal should be brought forward to full senate for a vote. Presentation of this to faculty senators will also help educate the faculty about this process.
