- 1. Kliewer called the meeting to order at 3:32 pm. Andy will be slightly delayed joining us so we'll start with item #3 first.
- University Calendar Committee Proposal Wildcat Pause Day (see handout) Bennett began by sharing that after the University Calendar committee's recommendation was shared with Faculty Senate on April 9th. He then had many conversations to see where people stood and how they felt about it. After doing so, he worked to craft a resolution that may be of help.

He noted that this committee is also being called upon to endorse/or not endorse the University Calendar Committee's recommendation. Therefore, there are two separate motions to act on, both today and at Faculty Senate in May. The recommendation from the University Calendar Committee and the resolution being presented by Senator Bennett for the Wildcat Pause Day resolution.

Bennett moved for Academic Affairs to approve the resolution presented for Wildcat Pause Day and forward it on to Faculty Senate for consideration. Motion was seconded.

Discussion: There was conversation about how best to help students and what documented evidence is available. There were concerns raised about having a fall break during the 7th week due to mid-terms being directly after returning. How will that impact faculty overall when they go to handle mid-terms etc. Part of why we want to do it a few times is so that faculty can see what the impacts are for more than just one year. There was also discussion of the intent of the break and practical implications. There was further discussion about the specific week and whether there can be flexibility.

Kouba moved to amend the resolution to be "a Friday in October, to be determined each year based on scheduling". Prakash seconded. Amendment carried. Motion to approve the resolution, as amended, carried.

Now the conversation is for University Calendar Committee's recommendation. Bennett moved to not endorse the University Calendar Committee's recommendation. Motion was seconded. Discussion: there was clarification why it was being declined. It was commented that it was because it's a permanent change, whereas the resolution champions a temporary change and a request for data to be collected. Motion carried.

Both of these items will be on the May Faculty Senate agenda.

 University Inclement Weather Policy – proposed change to PPM 3035 (Von Bergen/Saucier) Saucier and Von Bergen were present to share their proposal on final exams related to when there is inclement weather. After thoughtful discussion and conversation with various questions and concerns addressed, members were ready to vote on it. It was noted that if this proposed change to the PPM is approved by Faculty Senate and administration, it would then be appropriate for language to be crafted for inclusion in the University Handbook as well.

Kliewer moved to provide support and approval of this proposal to allow it to move forward with the next layers of approvals. This was seconded. Motion carried. Senators Saucier and Von Bergen will move forward with next steps.

4. University Excused Absence Policy – proposed change to University Handbook, Section F62 (from Student Support & Accountability - Andy Thompson) Andy Thompson and Laurel Moody both shared information regarding the proposal and how it came about. This has been given much thought throughout a year and a half of review and deliberation; it is believed this will be helpful to students. Kliewer moved to endorse the policy as presented. Prakash seconded.

Discussion: There were various comments shared. One concern was about adding the department and career fair days to the absences excused at the instructor's discretion. This may need further conversation. Additionally, it was suggested that perhaps when there is a disagreement, the language could be changed to have that presented to the office of Student Support & Accountability instead of the dean.

Motion carried. The comments shared will be provided to Faculty Affairs as they will vote next on the proposal and then it may go to Faculty Senate for a final vote if there are no other votes needed.

Therefore, a motion was made by Kouba and seconded to table AP 541/641. Motion carried. These will be followed up on.

 A motion was made by Kliewer and seconded by Smith to approve the retro conferrals. Motion carried.
- 12. K-State Core proposals already approved; how to handle when errors are discovered after last FS AAC meeting in May discussion.

Kliewer shared that he and Brandon met with Tanya Gonzalez and the Registrar's office to approve an edit to a K-State Core curriculum that had been approved by this body, but then there was an error found with the documentation provided and it needed to be updated. A number of courses, within the licensure piece, were missing from the curriculum schema, but they were in the degree maps that had been provided. This specific change was approved to be corrected, having to do with licensure, and these types of changes will be cared for this way; however, some corrections will need handled on a case-by-case basis. A question came up about edits that need made to these after the FS Academic Affairs committee concludes meeting for the academic year. Should these be handled the way microcredentials are over the summer where the co-chairs (or at least one co-chair) and FS president are responsible for signing off, so to speak? Discussion ensued. This will need finalized before the last meeting.
