1. President-elect Julia Keen called the meeting to order at 3:31 p.m. and noted that President Bloodgood was not able to be with us today.

#### 2. Visit from Provost Mason

Provost Mason expressed her appreciation for all the work and effort that goes into making a commencement special. She brought one of the new commencement programs for senators to looks at. The program has changed considerably with small changes being made over time. She is looking for feedback on the commencement program so please forward any suggestions to her. The Kansas Board of Regents (KBoR) has asked the Regent institutions to address the issue of post tenure review. All K-State representatives have informed the regents of the procedures already in place at our university; however, the KBoR wants additional attention paid to post tenure review. Faculty Senate Leadership Council will have the FS Faculty Affairs committee begin work on this request in the spring. The search for the new dean for the College of Human Ecology is going well. Dean Dan Richardson's retirement from K-State Olathe was unexpected; however, the Provost is using this situation to think through this position. She is currently visiting with provosts from other universities that have remote campuses to see how they deal with them. She has received some helpful information. The goal is to charge a committee early in the spring 2013 semester. They will be contracting with a search firm, hopefully one from Kansas City, so they will be familiar with the Kansas City area. Until his retirement, Dean Richardson will be working half time. President-elect Keen expressed her appreciation for Provost Mason visiting FS.

#### 3. Visit from Art DeGroat – Update on Military Affairs

Mr. DeGroat opened by stating that Kansas State University will remain committed to promoting the success of its military connected students as it has throughout its 150-year land grant tradition. Currently there are 27,000 active soldiers within 90 miles of Manhattan, KS. Approximately 12% (2628) of our student base is affiliated with the military. He anticipates that these numbers will increase except for the number of ROTC students, which will stay the same or decrease slightly. His goal is to replace the phrase "military friendly university" with "military inclusive university". Nine years ago, he created a model for a comprehensive approach for creating an inclusive culture with military students which is a staged process as they pursue their degree, i.e. transition, persistence, success. DCE recruits active military individuals. We do not actively recruit veterans because if we create an inclusive culture for the military, they will come, as our numbers have shown. President-elect Keen expressed appreciation to Mr. DeGroat for his presentation.

       Senator Bennett moved to approve the new minor in South Asia Studies. Dr. Barry Michie was available to take questions. No discussion; motion carried.
    - 2. Curriculum deletions College of Technology and Aviation (K-State Salina) (Page 7) (Supplemental information in **Attachment 2**) Senator Bennett moved to approve curriculum deletions from the College of Technology and Aviation. No discussion. Motion carried.

Senator Bennett reported that the Interdisciplinary Task Force is close to finalizing their report.

B. Faculty Affairs Committee – Melia Fritch/David Thompson Senator Fritch reported that, because of her wealth of knowledge and background, Sr. Associate Vice Provost Ruth Dyer has taken the lead on the post tenure review assignment from the KBoR.

The KBoR would like regent institutions to develop a faculty award, the criteria of which would be developed by each institution. About five or six years ago this came forward and FS declined to participate in this award. Senator Fritch asked if FS is interested in developing this award and, if so, what the criteria for the award should be. She also noted that if we decline to participate, we might be the only institution to do so. Would faculty be comfortable with this? She would welcome thoughts and comments, which can be sent to her via email. If we are going to do this, we would like to respond soon, by the end of January 2013, if possible. Discussion followed. This is not a monetary award; the only apparent benefit is the opportunity to go to Topeka to receive the award. Other comments tended toward the position that spending time on an award that does not appear to have any intrinsic value would not be time well spent. The suggestion was made that perhaps President Bloodgood could determine what other institutions are doing while at the December KBoR meeting. This can be an agenda item on the February FS agenda in order to have a formal vote.

- C. Faculty Senate Committee on Technology Dave Rintoul
  Senator Rintoul reported that there is ongoing work on a new email and calendaring system. The plan is
  to give the CIO and Provost a list of recommendations and options around December 20, 2012.
- D. Faculty Senate Committee on University Planning Bob Condia
  Senator Condia reported that Captain Stubbings, KSU Police, visited their last meeting. The KSU
  Police consists of 23 commissioned officers, 10 non-commissioned officers, and one plain clothes
  detective. Statistics show an increase in the incidents of crime. Recently, there have been burglaries in
  Throckmorton and Seaton Halls. A burglary attempt in Durland was foiled. Crooks do not like to be
  seen so if you confront them, they tend to disappear. KSUPD has a good working relationship with
  RCPD. When handling dangerous situations, past strategy was to wait to see how things unfold; now
  they are instructed to engage in a disturbance. Property crime represents the largest percentage of
  crimes on campus with drugs and alcohol continuing at the same rate. Wildcats Against Rape works to
  ensure that victims know of all the avenues available to them. The Sustainability 2025 Task Force will
  be charged in January 2013. FSCOUP will have members on the task force. Senator Lynn Sherow
  stated that 2025 goals were broad, whereas they believe the sustainability task force will be ready to
  start discussing more specific goals on becoming more sustainable.

E. Student Senate – Emilee Taylor Senator Taylor reported that the Ayers Saint Gross master plan for the K-State Student Union is expected to be received in January 2013. Student Senate is looking at future tuition increases.

#### 7. Announcements

KSU Libraries is taking nominations for the Brice Hobrock Award. Information regarding the \$1,000 award can be found on the library webpage.

Cats in the Capital will be February 13, 2013. This is a daylong event at which Call Hall ice cream is served to legislators. Senators are encouraged to put this date on their calendars and plan to attend.

The Faculty Compensation Task Force report will be distributed to the President, Provost, and FS president on December 12<sup>th</sup>. The distribution process is yet to be determined. Senator Keen reported that she has advocated for having it disseminated during the break.

The Sesquicentennial Kickoff event will be held on February 14, 2013 in Ahearn. A special ice cream flavor has been developed in honor of this historical event.
