1. President Dave Rintoul called the meeting to order at 3:30 p.m.

- 2. The November 11, 2014 minutes were approved as submitted.
- Approval of Consent Agenda Fred Guzek (pages 4-5) Attachment 1
   Senator Guzek asked if there was any item that should be moved to the discussion agenda. Hearing none, he moved to approve the consent agenda. Motion carried.
- 4. Report from Standing Committees and Student Senate
  - A. Academic Affairs Andy Bennett
    - 1) Open/Alternative Textbook Proposal, action item Attachment 2 Senator Bennett moved to endorse the Open/Alternative Textbook Proposal and call the administration to fully fund it. Discussion included a question regarding accessibility, development of useful guidelines for faculty interested in the open/alternative textbook option, intellectual property (IP) and copyright issues, ownership of intellectual property, inclusion of an outcome and assessment component, and review of the textbooks. Motion carried.

Undergraduate research courses have been brought to the attention of Academic Affairs. Academic Affairs is looking into creating a template course form with variables that individual departments can edit to customize the course to their needs. These types of courses would be approved through the expedited process, therefore, approval would be final at the college level. It is hoped this might be forthcoming in February 2015. Discussion included questions about the situation where a department does not have undergraduate students but a lot of undergraduates do research in the department (this occurs in the College of Veterinary Medicine), and whether this would qualify as an undergraduate research experience. Senator Bennett promised to look into that during the forthcoming development of the course template.

- B. Faculty Affairs Betsy Cauble
  - 1) University Handbook, Appendix M revisions, action item Attachment 3
    - Clean version Attachment 3a

Senator Cauble moved to approve the University Handbook Appendix M revisions. Senator Glymour moved to amend the revisions by deleting the third sentence under Section #3, Composition and Eligibility, "Faculty of the college in which the faculty member holds an appointment shall not be eligible." Motion was seconded. Past President Keen provided background as to why the language was retained. Other senators spoke in favor of keeping the sentence. Substantial discussion ensued. The amendment was voted on; motion failed. The original motion was voted on. Motion carried.

- 2) Open Access Policy, first reading Attachment 4 Senator Cauble introduced Beth Turtle and Marty Courtois from the KSU Libraries who provided a brief presentation regarding Open Access. Discussion included the granting of copyrights into perpetuity versus non-exclusive license to the university, the requirements for 'opt out,' the effect on small scientific societies, staff members who are involved in publishing, citing of articles, Google searches, waiver (line 35) versus 'opt out', KREX taking advantage of editorial prerogatives of journals, and concern that it appears to be "policy language" which means this will be in the PPM. The intent is not to create problems for faculty but to support Open Access. President Rintoul reminded Senate that the policy was brought forward for a first reading. Senators strongly encouraged that changes be made to the policy language prior to its being brought back for a vote.
- 3) Procedural language regarding KBoR Social Media, action item Attachment 5 Senator Cauble moved to approve the procedural language regarding the KBoR Social Media. Discussion included the reason why this will be in the PPM rather than the University Handbook. Senators were concerned that changes could be made without Faculty Senate approval. Motion carried. It was recommended the University Handbook and Policy committee recommend to administration the inclusion of these procedures in the Handbook as well.
- C. Professional Staff Affairs Danielle Brown
  Senator Brown reported that the their committee continues to work on Section C of the University
  Handbook and is also working on the administrative review process with Cheryl Johnson, Vice
  President of Human Capital Services, President Rintoul, and others.
- D. Student Senate Cody Kennedy for Abby Works Senator Kennedy reported in Abby's absence. Student Senate is working on structural changes to the tuition strategies committee. Primarily the name has been changed to Tuition and Fees Strategies Committee. They are developing a standardized application for fee requests. On September 15, 2014, a new tutoring website was launched: <a href="www.ksu.edu/tutoring">www.ksu.edu/tutoring</a>. The website lists all the available tutoring options throughout the University. Senator Kennedy also spoke briefly about the Lifeline 911 resolution and policy, which will be discussed later in the FSCOUP report. Over 200 schools have such a policy and its importance needs to be emphasized. He ended with a favorite quote as finals week is nearing: "Success lies not in being the best, but in doing your best."
- E. Technology Don Crawford Senator Crawford reported that deadline to copy grades from K-State Online or CANVAS is 11:00 a.m. on Tuesday, December 23, 2014. About two weeks of CANVAS orientation training sessions will start on January 5, 2014 with 10:30 a.m. and 2:30 p.m. sessions conducted each day. The University replaced SafeTrack with the LiveSafe app. Office 365 is on track to complete phase two at the beginning of the Spring 2015 semester.

- F. University Planning Barbara Anderson
  - Student Senate's Lifeline 911 resolution and policy, action item Attachment 6
     Senator Anderson moved to support the Lifeline 911 policy as outlined in the resolution.
     Discussion included what the University's liability is with such a policy. Other comments and questions were also addressed. Motion carried.

Anderson announced that the University's Director of Governmental Relations, Sue Peterson, will be attending their FSCOUP meeting on Thursday, December 11, 2014 to discuss the upcoming legislative session. Senators are invited to attend if they wish. The meeting will be held in the Konza Room of the K-State Student Union at 3:30p.m.
