- 1. President Andy Bennett called the meeting to order at 3:31 pm.
- 2. Guest: Provost April Mason Topic for discussion: Criteria for Targeted Budget Cuts
  Provost Mason indicated that the Budget Advisory Committee and administration are investigating ways to
  use targeted budget cuts in the future instead of across the board cuts. The Budget Advisory Committee is
  in the process of putting the budget together and are looking at targeted budget cuts for FY18. Provost
  Mason said it would be premature to talk about the indicators to be used for targeted budget cuts as these
  have not yet been determined. A senator urged Provost Mason to move forward with targeted budget
  cuts. Provost Mason said there are committees looking at ways to change our financial models, including
  the Administrative Efficiencies Review Committee, co-chaired by Cindy Bontrager and Jeff Morris, and
  others looking at various tuition and fees models.

A question was asked whether new hires would be administrative positions. These are not faculty hires; these hires are mandated by others. The three positions are:

- Risk Management position
- Chief Information Security position (came out of state legislative post-audit report that we are required to have)
- An additional Clery Investigator

A senator asked a question regarding safety regulations once concealed carry goes into effect on July 1, 2017. Provost Mason said Cindy Bontrager has asked for additional police officers, and there will be educational programs to address safety concerns. The weapons policy approved by the Kansas Board of Regents for K-State is on the Vice President for Administration and Finance website, and this includes information on storage and training. This policy is not in effect until July 1, 2017.

- 3. The February 14, 2017 minutes were approved as submitted.
- 4. Approval of consent agenda (pages 6-7) Brian Lindshield Attachment 1

A motion was made to approve the consent agenda. Motion approved.

- 5. Report from Standing Committees and Student Senate
  - A. Academic Affairs Jenny Bormann / Teresa Hartman
    - Discussion agenda (page 8) Attachment 2
      - i. A motion was made to approve the Computer Science proposal. Motion approved.
    - Contractual market-based education Proposal for Board of Regents Attachment 3
      - i. There was a proposal from the Provost's Office for Contractual market-based education. If approved by the Board of Regents, the university would have the freedom to offer courses for credit at a different tuition rate than the standard tuition rate. A motion was made to approve this policy.
      - ii. In October, 2015 Wichita State came to the board with a similar proposal. This past year Emporia State came forward with a similar proposal. Two K-State deans indicated they have been approached by industry and K-12 teachers who are interested in participating in an educational training for a fixed market-based rate. At this point, it is starting with non-degree seeking students. Units will need to go through an approval process prior to offering such courses.
      - iii. These market-based programs will be available to non-degree seeking students. If this were to change in the future to be available to degree seeking students, the proposal would need to go through Academic Affairs.
      - iv. It is not certain where the money from these courses will go at this particular time. Cindy Bontrager, Vice President for Administration and Finance, assumes that it will be a shared model, similar to what is currently in place with Global Campus.
      - v. Motion approved.
    - University Honors Program course/curriculum approval process Attachment 4
      - i. It has been requested that the University Honors Program have its own prefix (UHP) so non-discipline related courses, like a freshman seminar, can be offered. A course and curriculum approval process has been developed for University Honors Program. A motion was made to approve the University Honors Program course/curriculum approval process.
      - ii. Proposals would be initiated by the University Honors Program administrative team, which consists of the director and associate director with consultation of three departmental faculty who were actively involved in teaching honors courses. At that point, faculty who are teaching in the UHP will vote on the proposal.
      - iii. A senator asked a question regarding where the student credit hours will go for courses approved under the new proposal. As it currently stands, student credit hours go to the honors program, and this will remain the same. Right now the only course they envision putting through this process is the Intro to the Honors Program (UHP 189; 1 credit hour), which would be a limited number of credit hours on the table.
      - iv. Motion approved.
    - Curriculog overview for Faculty Senators Charlotte Pfaff
      - i. Charlotte Pfaff provided a brief Curriculog demo to aid senators in understanding how to view proposals. This will be the central repository for course and curriculum proposals.
      - ii. Four colleges are currently piloting Curriculog, only for courses at this time, and the first batch of new proposals is in Curriculog.
      - iii. They are still working on single sign-on, and that will be in place soon.
      - iv. There is a website up with helpful information including password protected help guides: <a href="https://www.k-state.edu/curriculog">www.k-state.edu/curriculog</a>.
      - v. There will be a training session on Friday, March 17<sup>th</sup> at 1:30 p.m. in Fairchild 009 that everyone is welcome to attend.
    - Solar Eclipse Resolution

- i. Senators may recall a resolution was passed in the fall regarding the Solar Eclipse on August 21, 2017, which is the first day of the fall semester. Courses will not be cancelled during the solar eclipse, however, a request from the provost was sent to the Committee on Academic Policies and Procedures (CAPP) to suspend the policy of dropping students who do not attend the first day of classes for this day only. CAPP approved the following motion: Students cannot be dropped for missing class on Monday, August 21, 2017. The attendance policy (University Handbook section F64.3) will resume on Tuesday, August 22, 2017. This change will not affect any other university policies or deadlines.
- B. Faculty Affairs Jackie Spears on behalf of Charlie Barden and David Lehman
  - 2016 Faculty Salaries Report Attachment 5
    - i. A motion was made for Faculty Senate to receive the 2016 Faculty Salaries Report. Motion approved.
  - University Handbook, Section C update
    - i. The University Handbook is now updated and posted on the website. The following revisions are now updated: Section B, Section C, and Appendix Q. The updated policies in these sections will not be enforced until next academic year as some of these sections address evaluations, which are currently underway.
  - Faculty Affairs continues to discuss student evaluations.
  - It was asked if Faculty Affairs could get the regression equation for the TEVALs. Senator Spears does not have this information, but she will look into it. It was indicated that Jana Fallin has said she will share the algorithm for TEVALs, but Faculty Affairs does not have this information.
- C. Professional Staff Affairs Loleta Sump / Mary Anne Andrews
  - Jeff Morris and Derek Smith came to the last PSA meeting and spoke on Total Rewards.
  - PSA and members of the General University caucus developed a survey that was sent out to
    professional staff. The survey included open ended questions regarding general concerns and the
    type of evaluation system professional staff would like to have. This survey was sent to over 1600
    individuals and to date they have received over 400 responses.
  - Shanna Legleiter spoke to PSA regarding professional development needs assessment of faculty and staff; a survey has been sent out to all faculty and staff.
- D. Student Senate Jack Ayres
  - Student president-elect Jack Ayres indicated student senate is gearing up for the Big XII on the hill where students will advocate for various issues in Washington D.C., including college affordability and sexual assault.
  - The Tuition and Fees Strategies committee has reviewed the current fees in the College of Agriculture and Architecture, and have recommended to continue to approve these fees. The committee is now reviewing five new fee proposals:
    - i. Arts & Sciences
    - ii. Business
    - iii. Engineering
    - iv. Human Ecology
    - v. A university wide academic infrastructure fee
      - 1. The university wide academic infrastructure fee would go toward the central administration debt for the College of Business Building and classroom renovations.
      - 2. A senator inquired where the money would come from for this building that is already built if the committee does not approve the fee. This fee plan was denied the last two years, and came forward again this year for approval. It appears as though there is not another plan for how this building will be paid off.

- 3. A senator recalled that President Schulz pledged the \$15 million at the beginning of a \$50 million campaign to raise funds for the business building. Even though this is a business building, students from across campus use the business building and next year classes from across campus will be held in the building.
- 4. The challenge, though, exists in that students were not asked about the fee until after the building was built and they are struggling with paying the fee as an afterthought.
- E. Technology Don Crawford on behalf of Lisa Shappee and Michael Raine
  - A draft of the annual Data Access Report was provided by interim CIO, Rob Caffey. That report will be presented to Faculty Senate in the April meeting.
  - Student response system should the university look into a university-wide student response system with central support or to continue to have departments and colleges. They are seeking input on this. Please email Scott Finkeldei with your feedback.
- F. University Planning Spencer Wood
  - Committee members continue to review guidelines regarding emergency furloughs and are working to submit further revisions. Some language is not clear so efforts are being made to clarify it.
  - They met with Ethan Erickson to gain a better understanding of the budget.
  - FSCOUP will also work on their City/University fund proposals now to prepare to work with USS and Student Senate in the fall for a joint proposal to go forward.

#### 6. Announcements

- A. Faculty Senate annual elections are in process.
- B. Report on February 15 Kansas Board of Regents meeting KBOR adopted the weapons policy at their December meeting, but they are now starting to work through the areas regarding what counts as restricted access. It is expected that there will be no difficulty with the BRI or the reactor. The chemical storerooms seemed likely to be accepted as restricted access. However, it is unclear if the child development centers will be allowed as restricted access. Because this issue was discussed in executive session, we do not know KBOR's reaction and what the final ruling will be.
- C. Endorsement of the Principles of Community update
  President Bennett reported that the Principles of Community passed every group with two groups
  using the same wording and everyone else coming up with slightly different wording. The various
  group leaders have agreed that the Principles of Community will not say family or community, but will
  instead read, "We stand opposed..."

#### 7. New Business

- A. Resolution regarding K-12 Attachment 6
  - A motion was made to approve the K-12 resolution. Motion seconded.
  - Senator Hedrick said he has been watching the gradual erosion of tenure overall (in this case due process for K-12). He indicated that this is a slippery slope for our institution in higher education as well as on behalf of the future K-12 students who are educating and sent out into the state for employment.
  - Motion approved.
