 President Tanya González called the meeting to order with a land acknowledgment. She then thanked senators for their ongoing dedication and hard work to meet the challenge of providing education during these changing times. She expressed care for the health and safety of all senators and their loved ones. There was also a moment of gratitude, for senators going above and beyond, leading colleagues in a time of change and anxiety. She noted our Employee Assistance Program available to help us all cope with the stress and anxiety at this time: 888.275.1205, press option #1.

The Zoom chat was saved for the purpose of minutes, so comments and questions or concerns were encouraged in the chat section.

She also shared some standard operating guidelines with senators due to our full meetings being conducted via Zoom. These helpful tips were also provided via email.

- 2. President González inquired if there were any changes to the draft minutes of the February 11, 2020 meeting. Seeing none and with no objection the minutes stood approved as submitted.
- 3. Guest: Provost Charles Taber

Topics for Discussion: Covid-19 update

President González welcomed Provost Taber and expressed gratitude in his leadership and communication to the campus. Provost Taber shared a brief highlight of the COVID-19 response and activities over the week.

- To address the issue of community health the decision was made to move classes to distance format.
- To reduce the transmission of the virus, increasing social distance and eliminating face to face contact was strongly recommended.
- The aim now is to continue to serve our community in teaching and research.

- Postponed visits to our campus, canceled in person events and meetings, eliminated in person travel outside the state, worked to close the housing and dining center, with some students accommodated, including international and those who have no other housing available.
- Decision was made to move the work of employees, including student workers, off campus. Ensured continued pay; we value them and will continue to support them.
- Process began to identify employees who are critical to be on campus. We need to know who, when, and how often those people will be on campus. The buildings will be locked, and they will have access.
- Some buildings will be shut down to eliminate daily care beyond a walk through.
- Only those absolutely necessary should be on our campus.
- We have acknowledged that this will be for the rest of the semester, an eight-week interruption. This means an in-person graduation will not be held.

Discussion: Some questions were received prior to the meeting via email. Others were raised during the meeting.

- Is there thought of extending the semester into the summer? At this time, we will not extend the semester. However, this is a fast-changing situation and at times what we think we know today we learn tomorrow that we must take a different course.
- Will the campus shut down all together and when may this happen? We are serving our educational
 function fully and identifying critical research for which we have contracts and grants that must be
 completed. We have facilities where animals will need care, so we do not see a full shutdown of
 operations.
- Now that we have solved student access to materials, the faculty will need time to pick up materials.
 Can we have those 10 days too? There will be time to retrieve materials with careful social distancing.
 All faculty will have this opportunity through an orderly process.
- Will mail service continue? Yes, but in modified ways. For the buildings shut down, the mail will be at central mail. Other buildings who have employees working in them will still get mail. Deliveries to campus are allowed, but there will be continued guidance from Cindy Bontrager.
- What about research that is not mission critical and can be done with social distancing? Yes, please communicate with your department. Do not come in and hold lab meetings, but find ways to communicate that are safe.
- o If we get booted off a zoom meeting, what is the protocol for continuing the session? There is concern over infrastructure that is out of our control. We have discussed asynchronous class elements, that are not tech dependent. CIO Pratt also added there was a stress test done last week and bandwidth was being looked at. There is a committee working on this and other issues. It was also commented that some who were having issues had children at home doing online gaming and/or video streaming, so keep this under consideration and pay attention to the usage.
- Payment of students not working is a great hardship on research and teaching units in Animal Sciences and Industry. The principle of payment for no work seems to be a dangerous precedent. We operate revenue-based units that cannot afford payment for no work. It was responded that we have an ask out to the legislature, to support students and employees. We may have to take steps away from this if the funding request is not granted. Universities are going in with at \$20 million dollar ask.
- It seems like "critical" research will be defined by the VPR; however, some other information makes it seem that it's up to the deans. Clarification is requested. Can our Machine Shops stay open? They are usually one-person operations; therefore, social distancing can be maintained. It will be up to the researcher explaining to the dean what is critical. CIO Pratt added that there has been a concern about researchers wanting to bring home confidential or proprietary data. This needs to go through the VPR as it could create a security risk.

Provost Taber thanked all for the work they are doing and realizes how hard this is to do. President González stated that with limited time together other questions will be forwarded to the correct people and groups.

Other questions to be shared with the Provost are: At what point might we expect guidance for when teaching faculty may fall too ill to conduct teaching? Will there be a delay of tenure clock considered for tenure track faculty whose research is negatively impacted? What will happen with teaching evaluations, especially for untenured faculty, through the stretch of online teaching? It's possible there will be a potentially unfavorable impact, due to the circumstances, on these evaluations. Graduation was asked about and whether K-State, being a student centered university, could do a departmentwide or collegewide announcement of graduates online with their photo, at the end of the semester in place of commencement to give them a temporary closure on the their academic success until other arrangements made in the future?

These and other questions will be shared with the Provost. President González did respond on a couple of the questions noting that there have been discussions about adjustments to promotion and tenure processes and teaching evaluations. Communication with faculty will continue on these matters.

4. Guest: Dean Lori Goetsch & Monograph Collection

President González welcomed Dean Goetsch for an update about the Library and what is available.

Dean Goetsch reported this is our second go around with disaster preparedness to provide services of the Library. We have been getting many requests within Library Loan to get those materials out to you. We are working on how we can get items sent to homes, with a return envelope.

Reserve materials will go online, through scanning. We continue to work on collections and the collection curation project. We have librarians who will work with you on the process.

It was asked if there will be a decontamination of materials mailed back to the library? Yes, the books going out and coming back in will be cleaned and disinfected just as they have been through the fire recovery process.

Accessibility of material is an issue. Students will have materials after March 30, so we need to make due for those first two weeks of courses until students move out of on campus housing.

With limited resources, we may have questions about copywrite and fare use. Librarians Ryan Otto and Emily Finch have experience with copywrite questions so please use them as a resource. It was reported by a senator that Pearson has made some of their e-books available free of charge for classes using them for this semester. The bookstore is working with Follett, to make free resources available through the bookstore.

President González noted that the librarians have been so helpful on many campus committees and thanked them for their work and expertise. Dean Goetsch encouraged all to check the Library website for more information or email her at lgoetsch@ksu.edu with other questions.

5. Approval of consent agenda (pages 7-8) – Mindy Markham
President elect Markham inquired if any items needed moved to the discussion agenda. Seeing none and with no objection, the consent agenda stood approved.

- 6. Report from Standing Committees and Student Senate
 - A. Academic Affairs Todd Easton/Don Von Bergen
 - Proposed Mental Health Optional Syllabus Statement Attachment 1
 Von Bergen moved to approve the proposed optional syllabus statement. No second is required.
 The Academic Affairs committee was thanked for their work on this. Motion carried.
 - B. Faculty Affairs Don Saucier/Annelise Nguyen
 - Proposed University Excused Absence Policy (1st reading) Attachment 2
 Saucier presented the proposed policy for a first reading. President González reported that some changes for continuity will be made that were shared by Executive committee members already. However, if you have further questions or comments, please reach out to members of the Faculty Affairs committee to have these discussed. Some of the language in the federally required accommodations is inconsistent and this will be cared for.

Saucier reiterated that feedback is welcome and appreciated. If you have specific line edits, we are happy to review those as a leadership team. This is a policy that was started with USS, faculty senate, and student senate. One situation that lead to this policy development was that there were athletes not permitted to take exams because of being absent due to service in representing the university. If students are representing us we need to ask our faculty to make accommodations. DSOs are the main consideration for this policy.

It was inquired whether departments could be allowed the flexibility to tweak the rules? How much tweaking would be allowed? If we are going to have a policy it has to be a policy. It was acknowledged that there are extenuating circumstances, but there should not simply be an opt out. However, it seems reasonable to have language to allow a department to reach its educational mission. This will be discussed further.

There was concern about the language: "When a student provides reasonable advance written documentation of the need for a University Excused Absence, in accordance with the provisions below, instructors are expected to provide the opportunity to make up any assignments, activities, and/or attendance-specific points that contribute to the course grade." A senator shared their experience where there were at one time eight athletes who missed 12 classes each, which caused many hours of make-up work for this class. They then decided not to allow make up quizzes. Not distinguishing between important work towards their grade and small-scale quizzes, is a bit of a problem with respect to course load. It was responded that not giving a make up would be counter to this policy. It was noted that with the future implementation of this policy, if passed, there are changes that would need to be made to come into compliance.

A senator spoke in favor of the proposed policy and would like to recommend that somewhere early in the document "activities" be replaced with "responsibilities" to acknowledge how the university depends on students... the institution relies on the intellectual and other labor students offer through such activities, which distinguishes them from other kinds.

It was noted some text needs to be corrected: "the student shall coordinate with their instructors, advisor."

- D. Student Senate Hannah Heatherman
 - K-State Proud: They are continuing to meet virtually, so there is some potential for continued Student Opportunity Awards this semester.
 - SGA Resolution, Commitment to Uphold an Inclusive and Welcoming Campus **Attachment 3**This came about with discussion about the legality of student funding being sourced to bring in any speakers they want to hear from. The resolution is an affirmation of the positive outcomes to our structure that have occurred over the last several years.
 - We are continuing FY21 contracts and reservations, where elements cannot be refunded due to no travel or cancellations, requests need to be back to SGA by Monday to put on the agenda for discussion.
 - President González commended SGA on their response and resolution demonstrating leadership in continuing to have a welcoming climate at K-State.

- F. University Planning Brad Behnke/Laurel Littrell
 - Classroom Willard 114 will be renovated this summer. Renovations for summer 2021 are being
 considered and information about what classrooms are selected and the impact on capacity will be
 reported when decisions are made.
 - Research enterprise continues to be studied, looking at barriers to encouraging people to pursue grant funding.
 - Funds from the e-scooter implementation will be added to the City/University funds for next year, with proposals due on November 1 deadline, so the three senates are considering ideas now.
