- 1. President Mindy Markham called the meeting to order and played a land acknowledgement video by the Native American Student Body.
- 2. The October 13 and December 8 minutes were approved as submitted.
- 3. Guest: Provost Chuck Taber

Topics for Discussion: Budget and Vice President for Research updates Provost Taber reported that the governor made her budget proposal last month. It includes the single largest state cut for universities since 2009. It would lead to a \$9.5M budget cut for K-State, this is a 5.5% cut. It is important to recognize that this is the first step in a budget cycle, we will continue working with legislative review and discussion.

He also was delighted to report that Beth Montelone has been selected from an internal search process as the Interim Vice President for Research. The position for the Vice President for Research has been announced and we are receiving applications and materials. The deadline is February 19 with a June 1 start date. As for the Sponsored Research Overhead (SRO) or Facilities and Administration (F&A) task force, the final report has not yet been delivered but is expected soon. This taskforce, in part, discussed whether the current distribution needs to be changed, where central keeps a certain percentage and distributes the rest to the colleges.

#### Questions/Comments for the Provost:

If the governor's budget cut is not changed, what is the outlook? The enrollment is down, but not as far down as original projections. Between less state support and greater enrollment, we will be where we originally projected. But it will still be a difficult budget year, which we anticipated.

Are we anticipating furloughs? It is too early in the budget cycle to know whether there will be furloughs, however, we will set targets for units and request budgets for evaluation and make final budget decisions.

Does the looming budget make the KBOR proposal more attractive? No.

Is there any movement on the dependent grant tuition being extended to term employees? It is more expensive than had been calculated, we do not think it is wise to pursue that action this year. When we have solid numbers, we will have a discussion again.

*Comment:* Thank you and President Myers for not accepting the KBOR proposal, the Faculty Senate joins in thanking you.

Is there anything we as Faculty Senate can do to give you more support to make your position easier to maintain? We need to keep working through our shared governance process, that is how we address this.

#### 4. Guest: Foundation CEO, Greg Willems

President Markham welcomed Greg Willems to Faculty Senate.

Willems has been here at KSU for six years and is pleased to share the foundation impact report with Faculty Senate. These reports are produced for each college and for the university. The results are \$185M range for a three-year fundraising average. Due to Covid, our fundraising has been disrupted, but our investment has grown to \$141M. All funds are currently at full distributions. Endowments have grown by nearly \$11M in the past year, to have us surpass \$740M.

The decision for a long-term sole source contract with the Foundation provides consistent, stable, and longer commitment of shared funding. While state funding and tuition are the first two sources for funding the University, the foundation is the third source, delivering nearly \$92M a year in scholarships and other support. The foundation is the only stream of funding that is growing. We have set our goals from \$170M to \$230M in the next seven years. We have asked for the University partnership to provide a base for this process.

Foundation has a pool for performance-based raises, and cost of living adjustments, for foundation employees. We have a competitive market for talent. Willems met with the University Distinguished Professors for ways to partner and showcase the research of the University to our donor base. As the state has walked away from facilities investments, the foundation has secured millions of dollars for infrastructure. We have elevated what we are doing for need-based aid for students. All new facilities are exclusively funded through philanthropy.

Thank you for your commitment to research. Could there be some help from the foundation to do some fundraising that can extend to the departments? The benefits for your staff that are being provided the campus employees do not receive. We did receive gifts for furloughed staff, at about \$500,000 and similarly supported the student side.

What percentage is for Athletics, and what percentage is for Deferred gifts. When I arrived, athletics was outsizing the university. Now, fundraising for Athletics is \$35M per year, vs \$155M per year for the Academy.

5. Approval of Consent Agenda (pages 7-8) – Laurel Littrell
President Elect Littrell inquired if there were any items that needed moved to the discussion agenda.
Seeing none, and with no objection, the consent agenda was approved as submitted.

#### 6. New Business

A. Statement against Temporary Policy for Covid Related Reductions in Force – **Attachment 1**President Markham directed senators' attention to the statement included with the agenda. This document was prepared by the Council of Faculty Senate Presidents and is being presented to various regents' institutions for action. Various requests for input were made and edits were included. Additionally, it is being voted on by multiple bodies. Therefore, this statement is before senators today, not for a re-write, but to be voted on as presented.

President Markham entertained a motion and second to approve the statement as presented. So moved and seconded.

Discussion included reasons why KU has started the process to create a plan to use the Policy including a possible \$75M deficit, who this statement would be shared with, noting that those who selected the board or the legislature should be on the list to receive the statement. Question posed, is there advice from the University to whom the statement can and cannot be distributed? Senators expressed thanks to those who wrote the statement. This statement provides a voice for us.

Motion carried, though not unanimously, to approve the statement.

    - Covid-19 Impact statement Attachment 2

The challenge we have faced to do our jobs has been great. The statement provided is to assist in documenting the ways it has been detrimental to our progress. Conversely, it also provides an opportunity to share the successes despite the difficult times. As a committee, Faculty Affairs wanted additional ways to acknowledge this important information, besides allowing people to not submit teaching evaluations and pause the tenure clock. Submitting an impact statement provides a way to include professorial performance, post tenure review, and other elements. Covid-19 has impacted us in our personal lives, the health care concerns, mental health concerns, childcare, elder care, and the way we do our jobs. This has made it challenging to be productive at our normal levels. It was added this is not asking for faculty to disclose anything personal.

There was clarification requested about who is the person recommending a statement be submitted? The Provost and FS President will send a joint memo through the University leadership listserv and unclassified employee listserv to give people the opportunity to submit a Covid-19 impact statement.

What time period does this cover? It would be the next period, 2021. However, all Covid impacts since March 2020 can be added to this statement. To those whose RSCAD has been impacted, it was noted that the impact may not be seen for several years. This is to stay in your portfolio and it can be added to as needed. You would have the opportunity to adjust it as more impacts occur.

What if this conflicts with the department requirements for tenure, such as those where numbers are written as expectations? I would expect that departments would adjust proportionately. Could this,

by coming from the provost, supersede the written standards? In general, we do need to think about these types of situations and help faculty affairs consider new language to provide flexibility and uniformity and consensus around the process. Could we see some wording that has language to the effect?

This impact statement is guidance to ask for a statement from everyone, it does not supersede department documents, nor the handbook. It will be an addition to these documents. These statements can include both negative and positive impacts.

Senator Dodd spoke in favor of this proposal and made a motion to amend the following sentence in the statement to read: "All faculty members should prepare a "COVID-19 Impact Statement" for inclusion in their dossiers for any future reviews, including annual reviews and, promotion and/or tenure reviews, post-tenure reviews, and professorial performance awards, beginning in Spring of 2021."

Senator Von Bergen seconded the amendment. Amendment carried.

Senator Von Bergen called the question. Motion carried.

Motion carried to approve the statement, as amended.

Gratitude was conveyed to Faculty Affairs for their work and specifically to Past President González for her work on this proposal.

#### C. Graduate Student Council – Hannah Shear

Provost Taber was the guest speaker at Graduate Student Council recently and he addressed their questions. The Council has relaunched the professional development certificate in partnership with the Writing Center, Library, Career Center, and the Academic Achievement Center. Three-minute thesis competition information has gone out.

#### D. Professional Staff Affairs – Maria Beebe/Mishelle Hay McCammant

There was a joint meeting with Faculty Affairs in January that resulted in a proposal for term representation in the senate. This proposal was sent on to President Markham and is now under consideration by the FS constitution committee.

#### E. Student Senate – Nathan Bothwell (Maggie Billman)

No major updates, elections are in full swing, primary election deadline is this Friday at 5pm. Student Senate general election filing deadline is Friday, Feb 19 at 5pm. Primary elections take place on Feb 23/24, and general elections are March 9/10. Presidential debate this Friday. Best wishes to Senator Billman on her primary elections.

#### F. Technology – **Brett DePaola**/Michael Raine

FSCOT will likely be meeting twice a month with a heavy load this semester. Last meeting was looking at different policies on campus and doing fact finding. There is increased desire by IT for faculty and staff to weigh in via shared governance. We learned of the sunset on retention of Zoom recordings, six months effective after July 1, 2021 those files are deleted. You can move them to MediaSite, via a convenient way to be shared and advertised. In recent weeks we have seen a new live closed captioning. Though this is very helpful, we are reminded this does not satisfy our legal closed captioning requirement. This knowledge will help our future discussions.

G. University Planning – Brad Behnke/**Dan Ireton** 

There was a study completed on North Manhattan avenue, and intention to add traffic signals at Vattier, Thurston, and Petticoat Lane and a flashing beacon at Old Claflin road. Improvements on Denison, Sunset, and Hunting. Also, on North Manhattan Ave, the bike lane will become a two-way bike lane only on the west side of the street. FSCOUP discussed the merger that will happen with the Gender, Women, and Sexualities Studies and the American Ethnic Studies departments. This is internal to two departments within the same college, therefore, a FSCOUP representative is not required for those meetings. It would fall within the college's committee on planning in Arts & Sciences.

Senators initiated discussion on whether KSU should put out our own statement against the KBOR policy, and perhaps consider a vote of no confidence. Wichita State and Emporia State have passed their own resolutions,

these can be shared. It was discussed that KBOR advocates the governing system in the state for our funding. If they see this policy as necessary, we could invite them to help us understand why it was enacted. Could this be a KBOR town hall? At every KBOR meeting, the chair of the Council of Faculty Senate Presidents, approaches the chair to give viewpoints. This could be a time to ask these questions. The initial recorded sessions did provide general info on the financial challenges that our institutions are under. They did not provide specific information.
